**Treasurer Report: Treasurer** Rory Cherry reported the Financials in the meeting. As of July 31, 2023, the C.D.'s of \$135,940.81; Savings accounts of \$66,290.05; Checking Account \$103,379.57, and Petty cash for a total of \$305,773.43. June 31<sup>st</sup> Bank Balance was \$26,909.94 plus income of \$100,035.13 in July, less expenses of \$23,565.50, less outstanding checks of \$2,606.11, New Uncleared Deposits and Credits of \$2,421.13 and Uncleared Balance of \$114.94 July 31<sup>st</sup>, brought the July 31<sup>st</sup>, 2023, Statement Balance to \$103,494.51. The Cash Flow was \$76,469.63 for the month of July. Our Income is 95.79% of our recommended Budget for the year 2023.

**ACC Report: ACC Committee Member** Chris Glenz reported ACC Permit Fee Income for July 2023 was \$2,9994.60 for a total of 13 permits issued.
